### <u>Abortion</u>

In 2017, 862,000 legal induced abortions were reported to the CDC from 49 reporting areas. The abortion rate (number of abortions per 1,000 women) was 13.5%.

### Planned Parenthood

"Two bioscience companies have reached a \$7.785-million settlement with the Orange County district attorney's office over allegations that they illegally sold fetal tissue to companies around the world, prosecutors said Friday. According to the settlement signed Monday, DV Biologics LLC and sister company DaVinci Biosciences LLC, both based in Yorba Linda, must cease all operations in California within 60 to 120 days. The agreement also requires the companies to admit liability for violations of state and federal laws prohibiting the sale or purchase of fetal tissue for research purposes, prosecutors said." "The debate this year in Washington over infanticide is rightly shocking to many because it tragically flows from the abortion industry's advocacy for late-term abortion in states like New York and Virginia" (*ERLC Weekly*, September 13, 2019)

The New York Senate passed a bill in January of this year that includes the most significant expansion of abortion rights in the state in almost 50 years. The Democratic-controlled Senate voted 38-24 to pass the Reproductive Health Act on the 46<sup>th</sup> anniversary of the U.S. Supreme Court's landmark Roe V. Wade ruling that states can't ban abortion. This law would give women the right to an abortion after 24 weeks if a fetus is no longer viable, or if a woman's life or health is at risk. "The Born – Alive Survivors Protection Act seeks to protect children who survive an attempted abortion procedure and are born alive. If passed, the new law would require that abortion survivals be reported to law enforcement by the medical staff involved and that the surviving child be treated with the same level of medical care standard for any other child born prematurely. According to the bill's sponsor, Rep. Wagner, this legislation also takes the critical step to 'give the mother of the abortion survivor a civil cause of action and protection from prosecution, recognizing that women are the second victims of abortion and promoting the dignity of motherhood,' The vote failed 53-44 in the Senate in February. Since that vote, pro-life members of the House began an effort to force a vote in their chamber as well" (*ERLC Weekly*, September 13, 2019).

# V. Cultural Decay

Tim Keller in a message at Dallas Theological Seminary Hendricks Center said, "Throughout history all cultures have believed that truth was something out there that could be known. Feelings were internal. If the truth is - you shall not commit adultery, but I feel like I would like to commit adultery, I would bring my feelings in line with what was true.

We are the first culture in the history of the world where we are being told truth is within and on the outside are nothing but culturally constructed feelings. You find truth inside. You come out and you tell everyone you have to accommodate me, because I have found the truth - this is who I am and this is what is right or wrong for me.

It is the complete reverse of what has been traditionally understood.

If you talk to a Muslim, or a Hindu there is some agreement that truth is without. We all disagree on what the truth or sacred order is, but we all said the meaning of life is to sublimate your selfish desires and align with the truth. The meaning of life was to be good and to align your life with that sacred order. Our culture says exactly the opposite. The problem with this world is telling people they need to align with the truth. The solution is if every single person is able to define right and wrong for themselves and live as he or she seeks to live.

The culture of the past said the problem is the selfish autonomous individual; we must connect with the truth. But now culture says, Every single person must be free to define right and wrong for themselves and live as he or she seeks to live. Our current culture says the answer is the autonomous individual.
